1. The bidding company / firm/ suppliers must be a registered with FBR for Income Tax and Sales Tax.
2. The bidding company / firm/ suppliers must not be blacklisted by any Govt. or Semi Govt. organization
3. The bidding company / firm/ suppliers must not be involved in any litigation i.e. misconduct, fraud or disobey from Contract/ Agreement etc with any Government Department, Agency/ Organization etc.
4. The bidding company / firm/ suppliers should drop a single stage 02 envelope containing Technical and Financial separate Bids complete in all respects, signed, stamped, sealed and in conformity with Tender Documents should be dropped, in the Tender Box placed at the reception of the office of Secretary, Public Prosecution Department, Govt. of the Punjab, Punjab Civil Secretariat, Lahore on or before Date: 8<sup>th</sup> February, 2016 at 1:00 PM.  
by Bid Security at the rate of 2% of the cost of bid in the form of CDR from a Scheduled Bank in complete conformity with the clause "Bid Security" of the prescribed tender document. Bids which are incomplete, not sealed, not signed, not stamped received late or submitted by other than specified mode will not be considered.

The Bid documents along with required specifications of the IT Equipment can be obtained from Section Officer (General), Public Prosecution Department at 250-Riwaz Garden Lahore during office hours on payment of Rs. 1000/- (Non-refundable) through challan form to submit against subject tender in receipt head CO-3802 in NBP/ SBP.
7. The Bid shall be opened on Date: 8<sup>th</sup> February, 2016 in the office of Secretary PPD at 2:00 P.M. by the Bid Opening and Evaluation Committee in the presence of interested parties who may like to attend.
8. Income / Sales tax registration certificate and other documents as mentioned in Tender Document must accompany the bids. Taxes will be deducted as per GOP rules.
