Public Prosecution Department, Government of the Punjab, invites proposals for Procurement of Hardware/IT Equipment under the project titled Digitization / Computerization of Public Prosecution Department and Development of Monitoring and Coordination System (Phase-I) from the interested companies / firms during the current financial year 2014-15.

1. Be a registered firm / company / duly recognized under the laws of Pakistan.
2. Be registered with FBR for Income Tax and Sales Tax.
3. Not be blacklisted.
4. Not be involved in any litigation with any Government Department, Agency / Organization etc.
5. A single package containing Technical and Financial separate Bids, duly completed, signed, stamped, sealed and in complete conformity with Tender Document should be dropped, in the Tender Box placed at in the office of Secretary, Public Prosecution Department, Government of the Punjab, Punjab Civil Secretariat, Lahore on or before **16<sup>th</sup> October, 2014** till **02:00 P.M.** The same advertisement of this publication is also available on [www.prosecution.punjab.gov.pk](http://www.prosecution.punjab.gov.pk) & PPRA website.
6. All bids must be accompanied by Bid Security amounting to **2%** of the cost of bid in the form of **CDR** from a schedule bank. The tender / bid value in complete conformity of the clause "Bid Security" of the prescribed tender document. Bids which are incomplete, not sealed, not signed and stamped, late or submitted by other than specified mode will not be considered.
7. The bid documents alongwith required specifications of the Hardware / I.T Equipments can be obtained from Section Officer (General), Public Prosecution Department at 250-Riwaz Garden, Lahore during office hours on payment of **Rs.1000/ (non-refundable)** through Challan Form to submit against subject tender, in receipt **Head CO-3802** in National Bank of Pakistan/State Bank of Pakistan.

The Bid shall be opened on **16<sup>th</sup> October, 2014** in the office of Secretary, Public Prosecution Department, Government of the Punjab, Punjab Civil Secretariat, Lahore at **03:00 P.M** by the Bid Opening and Evaluation Committee in the presence of interested parties who may like to attend.
9. Income/Sales tax registration certificate and other documents as mentioned in Tender Document must accompany the bids. Taxes will be deducted as per GOP rules.
